BYLAW # 03-2023

A Bylaw of the RM of Garden River #490 to provide for the collection of service fees as provided for in section 8 subsection 1 clause i of the *Municipalities Act*

The Council of the RM of Garden River #490 in the Province of Saskatchewan enacts as follows:

1. This bylaw shall be known as the "Fee Bylaw."
